



## General Release of Claims and Indemnification

In consideration of being allowed to participate in recreational opportunities and activities as described herein above, I irrevocably and forever release and discharge Gary Cooper Performance Horses, LLC and any and all landowners on which the activities are conducted, and all of the members, employees, agents, officers, contractors and representatives of any and all of the foregoing from any and all legal claims or legal liability of any kind, nature and description involving or relating to property damage, bodily injury, or death suffered or sustained by me or any minor children I may have participating in such activities during my involvement, or my minor children's involvement in recreational opportunities and activities upon lands and premises owned, controlled, leased or operated by Gary Cooper Performance Horses, LLC or any of the foregoing named parties, including without limitation, any and all legal claims or causes stemming from alleged negligence of said parties. I hereby personally assume all risks in connection with my engagement in such recreational opportunities and activities and further release the aforementioned Gary Cooper Performance Horses, LLC, Gary Cooper and other named persons and parties, their employees, agents, officers, contractors and representatives from any harm injury or damage, including death, which might befall me, or any minor children who also may be participating as participant in

such recreational opportunities and activities including all risks connected therewith, whether foreseen or unforeseen. I further agree to indemnify and save and hold harmless Gary Cooper Performance Horses LLC, Gary Cooper, and any and all landowners on which the activities are conducted from any loss, liability, damage, or costs they might incur due to my engagement, or my minor children's engagement, in recreational opportunities and activities upon the subject lands and premises whether caused by the negligence or the releases or otherwise.

I AM AWARE THAT IT IS A GENERAL RELEASE OF ALL CLAIMS AND LIABILITY OF ANY KIND WHATSOEVER BY ME OR MY HEIRS, PERSONAL REPRESENTATIVES, SUCCESSORS AND ASSIGNS; AGAINST ANY OF THE AFOREMENTIONED ENTITIES AND INDIVIDUALS, AND THAT I EXECUTE THE SAME OF MY OWN FREE WILL. I FURTHER ACKNOWLEDGE MY UNDERTAKING TO INDEMNIFY GARY COOPER PERFORMANCE HORSES, LLC AGAINST ANY LOSS OF LIABILITY ARISING DIRECTLY OR INDIRECTLY FROM MY PARTICIPATION IN THE PERMITTED RECREATIONAL OPPORTUNITIES AND ACTIVITIES. MY VOLUNTARY EXECUTION OF THIS RELEASE AND INDEMNIFICATION IS A CONDITION PRECEDENT TO MY PARTICIPATION IN SUCH ACTIVITIES, TO WHICH I WILLINGLY AGREE.
